

SPIN & WIN

Promotion Terms & Conditions

1. Organisation

Radisson Hospitality Belgium SPRL/BVBA, a limited liability company incorporated under Belgian law, with registered address at Avenue du Bourget 44, 1130 Brussels, Belgium ("Radisson"), organizes a promotion, as further described in Clause 2 (the "Promotion"). This Promotion is operated on behalf of Radisson Hospitality Belgium SPRL/BVBA by its appointed agent, ContentLab, Amager Strandvej 60-64, 2300 Copenhagen S, Denmark (the "Promoter"). The following terms and conditions (the "Spin & Win Terms") apply to this Promotion. Additionally, the Radisson Rewards Terms and Conditions (<https://www.radissonhotels.com/en-us/terms-and-conditions>) (the "Radisson Rewards Terms") apply to participation in the Promotion, applicability of which shall not be prejudiced by the Spin & Win Terms. The Spin & Win Terms and Radisson Rewards Terms shall jointly be referred to as the "Terms". Any capitalized words not defined in these Spin & Win Terms shall have the meaning given to them in the Radisson Rewards Terms, if defined in the latter. Those who participate in the Promotion ("Participants") shall be bound by the Terms and are strongly advised to read and understand the Terms carefully before participating.

2. Promotion and Promotion Period

The Promotion is open from 9 September 2019 up to and including 15 November 2019 ("Promotion Period"). The Promotion contains the following: Participants will get the chance to spin an online wheel ("Spin & Win") when submitting an eligible booking request for a meeting or event at Radisson Hotel Group properties across Europe, Middle East and Africa. Each spin gives the Participant a randomized prize on the "Spin & Win" wheel. Every spin will result in winning one of the prizes listed under Prize in clause 3.

3. Eligibility and other conditions

In order to participate and spin the wheel, Participants must submit an eligible booking request for a meeting or event at a Radisson Hotel Group property across Europe, Middle East and Africa, except properties located in Italy. One spin per completed meeting or event booking request is admitted. The Promotion is valid only for Radisson Rewards for Business members with residence in Europe, Middle East and Africa, except Italy. Only one Radisson Rewards for Business account may earn points for each eligible meeting or event. The Promotion further applies only:

- to meetings and events (i.e. not to individual or group room bookings) inquired into and booked (i.e. signed contract) during the Promotion Period and fully taking place in the period from 9th of September 2019 up to and including 30 June 2020; to meetings and events.

To the fullest extent permissible by law, Radisson reserves the right to add, modify, or discontinue this Promotion with or without notice at any time. The Participant's prize will be transferred into the Participant's account within eight (8) weeks from payment and taking place of the meeting or event. Prize is personal to the Participant and non-transferable to any third party. The Promotion cannot be combined with other promotions, offers or discounts, except where these Spin & Win Terms explicitly state otherwise. The Promotion is commissionable.

ELIGIBILITY OF PARTICIPANTS:

- Participants must be 18 years of age or older to participate in the competition.
- This Promotion is open to Participants with residence in Europe, the Middle East and Africa, with the exception of Italy.
- This Promotion is not open to employees of Radisson or its subsidiaries or branches, nor to the employees of the Promoter or any other companies participating in the implementation of this Promotion. This exclusion also extends to family members of employees of these companies.
- The Participant is liable for any taxes that may apply to receiving a prize.

PARTICIPATING HOTELS:

- The Promotion is valid only for meetings and events booked at Radisson Hotel Group properties across Europe, the Middle East and Africa, except Italy.
- The Promotion applies only in relation to Participating Properties. The definition of "Participating Property" is defined in the Radisson Rewards Terms applies (without prejudice to the other provisions of these Spin & Win Terms and notwithstanding the application of the Radisson Rewards Terms as a whole to the Promotion).
- Participating Properties in EMEA are subject to change without notice; please inquire at the hotel whether this Promotion is available when booking an event or meeting.

HOW TO MAKE A BOOKING:

Eligible bookings can be made:

- 1) directly with the Participating Properties
- 2) through Radisson's corporate sales team
- 3) through third party/agents

PRIZE:

Each spin gives the Participant a randomized prize on the "Spin & Win" wheel; prizes include:

- a) 5,000 Radisson Rewards Points
 - b) 15,000 Radisson Rewards Points
 - c) 45,000 Radisson Rewards Points (limited to maximum of 5 winners)
 - d) 500,00 Radisson Rewards Points (limited to maximum of 5 winners)
- Prizes consist of Bonus Points. Bonus points are points that the Participant will receive in addition to the Standard Points Radisson Rewards for Business members are entitled to (Standard Points = five points per US dollar spent on events booked).

REDEEMING THE PRIZE:

Upon winning a prize, Participants will receive a voucher (in PDF format) which confirms the prize won. This voucher is automatically generated by the Promotion page. Upon confirming their event at one of our participating hotels, Participants must also show hotel representatives a copy of the voucher (electronical copy or print copy of the voucher) in order to be eligible to receive the prize. If Participants are unable to provide a copy of the voucher, they are considered not eligible for the prize.

ANY CIRCUMSTANCE BEYOND RADISSON'S OR THE PROMOTOR'S CONTROL), WILL RADISSON AND/OR THE PROMOTOR, THEIR OWNERS, AFFILIATES AND SUBSIDIARIES, AND THEIR RESPECTIVE OFFICERS, DIRECTORS, EMPLOYEES, REPRESENTATIVES AND AGENTS HAVE ANY LIABILITY OR RESPONSIBILITY WHATSOEVER FOR ANY LIABILITY FOR ANY INJURIES, LOSSES OR DAMAGES OF ANY KIND, INCLUDING WITHOUT LIMITATION, DIRECT, INDIRECT, INCIDENTAL CONSEQUENTIAL, PUNITIVE OR EXEMPLARY DAMAGES TO PERSONS, INCLUDING WITHOUT LIMITATION PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE ARISING IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY, PARTICIPATION OR ATTEMPTED PARTICIPATION IN THE PROMOTION.

6. Applicable Law and Jurisdiction

These Spin & Win Terms shall be governed by the laws England and Wales, without regard to the choice or conflicts of law provisions of any jurisdiction. Any dispute, claim or controversy, including any question with respect to its existence, validity, termination, nullification or effectiveness, arising out of or in connection with these Spin & Win Terms and/or the Promotion shall be finally settled by arbitration in accordance with the ICC Rules of Arbitration. The arbitral tribunal shall be composed of three arbitrators. The place of arbitration shall be Brussels. The language to be used in the arbitral proceedings shall be English.
